The Coalition identified 5 goals for ensuring access to arts education for all City School Students:

- 1. Work with the district to ensure every school has a sequential visual arts, music, dance, and theater specialist on staff, district-wide.
- 2. Ensure student access to the arts and cultural community by requiring all schools to provide a base minimum of programming from a menu of experiences every year for every child.
- 3. Improve the coordination, process, and marketing for in and out school partners to communicate with schools
- 4. Engage partners in providing Professional Development for teachers and principals.
- 5. Collect and publicly release data on student access to the arts. Data will inform strategy, coordination and developing programs that best serve the entire district.

The goals were presented to the School Board of Commissioners in February and will be presented to the City Council in Fall 2014 during the hearing.

#### **State Policy Changes:**

Governor Martin O'Malley through the unanimous vote of his P-20 Leadership Council has established a statewide Task Force on Arts Education in Maryland Schools. The Task Force is charged with presenting a report to Governor O'Malley and his council with recommendations on curriculum and instruction, policy and regulation, professional development, and resource allocation on September 16, 2014. Baltimore City has the opportunity, in anticipation of the Governor's Task Force report, to ensure that every school provides students with the arts education programs they deserve and that the state requires.

#### **City Policy Changes:**

Effective at the beginning of the 2013-2014 school year, Baltimore City Public Schools implemented the mandate of at least a half-time certified arts teacher in every building. This resulted in the first increase in the amount of certified arts teachers in the district in five years, and reduced the number of schools without certified teachers from 29 to 9.
